- 20. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the bidders who resort to canvassing will be liable to rejection.

Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and earnest money/performance guarantee will be forfeited at any stage whenever it is so noticed. BSNL will not pay any damages to the company or firm or the concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.

- c. No employee in BSNL/ Govt. of India is allowed to work as a contractor for a period of two years of his retirement from service without the prior permission. The contract is liable to be cancelled if either the bidder or any of his employees is found at any timeto be such a person who had not obtained the permission as aforesaid before submission of tender and engagement in the bidders service.

#### **General Instructions to the Bidders**

- 1. The intending bidder must read the terms and conditions of BSNL-EW 6 carefully. He should only submit his bid, if he considers himself eligible and he is in possession of all the documents required.
- 2. Information and instructions for bidders posted on the website shall form part of bid document.
- 3. Applicants are advised to keep visiting the above mentioned website from time to time (till the deadline for bid submission) for any updates in respect of the tender documents, if any. Failure to do so shall not absolve the applicant of his liabilities to submit the applications complete in all respect including updates thereof, if any. An incomplete application may be liable for rejection.
- 4. Those bidders not registered on the website mentioned above, are required to get registered themselves beforehand. The intending bidder must have a valid class-III digital signature to submit the bid.
- 5. On opening date, the bidder can login and see the bid opening process. After opening of bids he will receive the competitor bid sheets.
- 6. Bidder can upload documents in the form of JPG format or / and PDF format.
- 7. Bidder must ensure to quote the rate of each item. The column meant for quoting rate in figures appears in yellow colour. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO)
- 8. Even though any bidder may satisfy the above requirements, he would be liable to disqualification if he has:
  - **a.** Made misleading or false representation or deliberately suppressed the information in the forms, statements and enclosures required in the eligibility criteria document.
  - b. Record of poor performance such as abandoning work, not properly completing the contract, or financial failures / weaknesses etc.
- 9. If any information furnished by the bidder is found incorrect at a later stage, he shall be liable to be debarred from tendering/taking up of works in BSNL. The BSNL reserves the right to verify the particulars furnished by the applicant independently.
- 10. GST and any other tax applicable in respect of this contract shall be borne by the bidder himself. The bidder shall quote his rates considering all such taxes. The TDS as per the Govt. regulations will be recovered from the contractor.

#### 11. Tender Evaluation:

- (a) The evaluation and comparison of responsive bids shall be done on the basis of Net cost to BSNL on the prices offered inclusive of packing, forwarding, freight and insurance charges etc., but excluding GST. The bid with lowest net cost as elaborated above will be the L1 bidder.
- (b) Vendors should furnish the correct GST Rate in the price schedule. If the Input Tax Credit is found to be not admissible at any stage subsequently owing to wrong furnishing of GST Rate, then the vendors will be liable to refund such non-admissible amount, if already paid, along with penalty if charged by the concerned authority.

- 12. The Contractor shall, within a period of 30 days of imposition of any further tax or levy in pursuant to the constitution of (Forty sixth amendment) act 1982 give a written notice thereof to the Engineer-in-charge that the same is given pursuant to this condition, together with all necessary information relating thereto.

#### 14. Bye laws Indemnity against liabilities:

- a. The bidder shall comply with all bylaws and regulations of the local and statutory authorities having jurisdiction over the works and shall be responsible for payment of all fees and other charges and giving and receiving all necessary notices and keep the Engineer –in-charge informed about the notices issued and received.
- b. The bidder shall indemnify the department against all claims in respect of patent rights design, trademark or name of other protected rights in respect of any plant, machine, work or materials used for or in connection with the works or temporary works and from and against all claims demands, proceedings, costs, charges and expenses whatsoever in respect of or in relation thereto.
- c. The bidder shall defend all actions arising from such claims and shall himself pay all royalties, License fees, damages, costs and charges of all and every sort that may be legally incurred in respect hereof shall be borne by the bidder.
- d. All liabilities / penal recoveries on matters arising out of tax /levies such as incorrect deductions, discrepancies in the filing of returns, revised assessments by the concerned authorities etc., shall be borne by the bidder.

## Technical Specifications A. GENERAL

#### 1. SCOPE OF MAINTENANCE

- 1.1 HPAC Maintenance of the Technical/ Administrative/ Residential Building(s) as applicable in this contract means that all HPAC / Electro Mechanical Services included in the schedule of work are kept in healthy clean and working condition and wherever specified the operation of such of the electromechanical services are also carried out. Specific details of maintenance activities required with regard to each service are detailed under sections pertaining to that service / technical specifications.
- 1.2 Electrical maintenance shall be carried out as per instructions contained herein. However all other forms & instructions to be used shall be as per works instructions / forms & checklists etc., issued from time to time. Wherever the term maintenance appears in the technical specification, it refers to the service for which comprehensive maintenance is undertaken unless otherwise specified. However the services under operation shall be generally maintained clean.
- 1.3 Watch and ward of the installation under Operation & Maintenance shall be the responsibility of the contractor during the contract period.
- 1.4 After the contract period is over the installation has to be duly handed over to the new agency along with the record of test results of equipment & associated items. Under supervision of SDE (E)/JTO (E) in charge. However installation is to be taken over by the new agency for O & M within 15 days of award of work.

All the spares required for the repairs are to be arranged by the contractor without any extra cost. In addition to these, all periodic maintenance as per tender document should be carried out. The schedule given in the tender document is only to give an idea of the services to be maintained. But maintenance of all the allied components and accessories of each system will be under the scope of work. All major repairs and periodical maintenance are to be got done through specialized agencies only

#### 2.0 METHODOLOGY

- 2.1 It is presumed that contractor will provide minimum qualified staff at the site, which will be adequate to perform routine maintenance and operational functions. For optimum utilization one person can be responsible for number of services.
- 2.2 In case of faults beyond the capacity, contractor shall immediately provide extra-specialized work force so as to attend to the fault in minimum reasonable time without any extra cost.
- 2.3 At the start of work, firm shall prepare an inventory of service under maintenance jointly with J.T.O (E)/SDE (E), concerned.
- 2.4 Before start of the work complete equipments/services under scope of maintenance shall be thoroughly examined by the agency jointly with SDE(E)/JTO(E) concerned. All Defects/discrepancies should be brought to the notice of the SDE(E)/JTO(E) in writing within first 15 days of award of work. Defects/discrepancies agreed upon by BSNL shall be got attended by the outgoing agency before handing over the site to the new agency. If the outgoing agency fails to correct the defects/discrepancies within 15 days, the same shall be got done by BSNL at the risk and cost of the outgoing agency. However any defect pointed out beyond 15 days, the agency is responsible for attending to the defects/discrepancies. Where the maintenance is taken over, for the first time, the

defects / discrepancies shall be got attended by BSNL.

- 2.5 A complaint / fault Register as per annexure- III shall be kept up-to-date at site by the firm and the same shall be available for checking & verification.
- 2.6 Firm shall maintain logbooks as per annexure IV.
- 2.7 If during the period of contract, any of the PAC units/ window/Split units are added / altered, ,all inclusive comprehensive maintenance of the same shall be done by the firm, the rates will be regularized as per Clause -12 of EW 8. However in case of deletion of any PAC unit/window/split units, recovery shall be made from the bill of the contractor on similar lines.
- 2.8 The details in the annexure I are approximate to give an idea of services to be maintained. Any variation on higher or lower side shall deem to be included at the initial take over. However the tenderers are advised to inspect the site (s) and make them acquainted before quoting.

#### MAINTENANCE PERSONNEL

Since the firm will be doing the maintenance of critical services such as Air Conditioning responsible & trained person(s), should be able to take initial steps under emergency situation.

- 3.2 In the sites where operation is carried out, the firm shall maintain an attendance register which can be inspected at any time by the SDE/JTO. The workman shall not leave the duty point till his reliever has reported for duty. In addition to the attendance register, the firm shall abide by the attendance recording methods in vogue in the site of operation such as finger print scanning etc.
- 3.3 Agency shall issue identity cards to the workers and a list of personnel employed together with the copies of such identity cards should be submitted to SDE(E)/JTO(E) concerned.
- 3.4 The workers engaged by the firm should maintain proper discipline and good behavior with occupants. The firm shall remove such workers from the site whose behavior is found improper. Engineer in Charge's decision shall be final and binding.
- 3.5 The firm has to supply details as per annexure- II of all the workers likely to be engaged by it before start of the work.
- 3.6 The workers engaged by the firm should wear a uniform of Navy blue color/ Coffee brown with detachable badge indicating the name of the person and firm's name and printed "SAVE ENERGY" at the back of the shirt.
- 3.7 The sitting arrangement for the staff engaged by the agency, space, water, telephone and electricity shall be made available by BSNL free of cost.
- 3.8 Provision of Supervisor shall also be made as per standard form of contract (PWD8) which forms the part of this contract.
- 3.9 The firm and their personnel shall follow the attendance—guidelines / practices such as finger print identification, punch card etc., which are available or will be installed by BSNL in a later date.
- 3.10 The firm and their personnel shall also co-ordinate, operate and feed information on automatic data collection services/automation devices that will be introduced by BSNL at any date during the tenor of contract.

At the start of each month, the firm in consultation with the SDE (E) concerned shall prepare a Program for preventive maintenance if any, to be carried out during the month. The actual maintenance carried out shall be recorded in **Annexure-VII** at the end of each month as per

maintenance schedule vide Annexure-VIII

Firm shall submit bills along with a Certificate as per Annexure - IX

Firm Shall Carry out Capacity test of Package AC unit every Month as per Annexure- X

If during the period of contract, any of the HPAC's are added/ reduced, all inclusive maintenance & comprehensive maintenance of the same shall be done by the firm, the rates will be regularized as per Clause 12 of EW 8. However in case of deletion of any major services similar recovery shall be made from the bill of the contractor.

#### **COMMERCIAL**

The maintenance personnel engaged by the firm should maintain proper discipline and good behavior with occupants.

The firm shall remove such workers from the site whose behavior is found improper. Executive Engineer's decision in this matter shall be final.

Any damage to the installation (s) / building during the maintenance period due to the carelessness on the part of maintenance staff shall be the responsibility of firm & be replaced / rectified without any extra cost.

Any accident or damage during maintenance will be the responsibility of agency & BSNL will not entertain any claim, compensation, penalty etc. on this account or on account of non-observance of law to the work.

The BSNL reserves the right to carry out any work at the risk and cost of the agency, if the agency fails to perform any duty as per the contract.

The tenderer must obtain himself at his own expense all the information necessary for the purpose of execution, before tendering.

Only replacement of major equipments as specified in Part-IV of relevant sections under technical specification which is required to be replaced as a whole after due scrapping shall be the responsibility of the BSNL. Till such time firm has to maintain the life expired equipment.
- 4.2 Contractor shall comply with any inclusion/exclusion in the above items and/or their quantity depending upon site requirements. The decision of the Engineer in charge shall be final in this regard.
- 4.3The replacement of material shall be with the same rating and make as that of the original. The firm may also replace an item with energy efficient item wherever the same is available, upon intimation to JTO (E). However, in case of non-availability of a particular make, Engineer-in-charge will approve the alternate make.
- 4.4. Dismantled and unserviceable items for which a replacement is supplied, shall be removed from the site under intimation to the JTO(E).
- 4.5 All materials shall be of approved make, model and capacity and shall be matching to the system.
- 4.6 Supplier Invoice/Bill / Purchase particulars shall be produced in case of all major items such as compressor etc. as a proof of genuineness. For replacement compressor, the firm shall produce necessary documentary proof. Obsolete items not available in market can be repaired and re used. However efficiency of compressor shall be ensured to avoid penalty under relevant clauses.
- 4.7 The contractor shall maintain minimum inventories with them in addition to items/spares mentioned under specifications as section 4.1 above. However the items/ spares which are not relevant to particular site need not be maintained.

#### (B) TOOLS & PLANTS:

- 4.8. All tools and plants, testing & safety equipments required for carrying out various tasks relevant to operation and maintenance have to be arranged by firm at its own cost.
- <u>a.</u> Wherever the firm is carrying out the Operation and maintenance of equipment, the firm shall possess the following minimum T&P at that site.

iv. Empty cylinder with cap & valve

v. Vacuum cleaner

vi. Vacuum pump (1/4HP)-Two state Rotary pump

vii. Oxy Acetylene torch & welding set

viii. Swaging tools

ix. Gas charging manifolds with discharge and suction gauge

x. Vacuum gaugexi. Flaring Toolxii. Soldering Gun.xiii. Pressure Guage.

- 4.9 The above list is general and any other requirements for smooth maintenance of installation shall be contractor's responsibility and he shall not claim anything extra on this account.
- 4.10 The firm shall also coordinate with the JTO (E) / SDE (E) for carrying out energy audit/capacity test at site. With respect to AC package unit.
- 4.11The Firm/Contractor will provide the maintenance personnel with necessary Testing and Safety Equipment.

#### **5.0 COMMERCIAL.**

- 5.1 The tender must obtain himself on his own expenses, all the information necessary for the purpose of tendering, inspect the site and acquaint himself with all the local conditions, means of access to work and nature of work etc. No claim shall be entertained on this account.
- Payment shall be made on quarterly basis after completion of maintenance period and on submission of bill in printed letter head together with requisite certificate and documents as per Clause 14 of Important instructions to Contractors and annexure VI & VII.
- 5.3 The rates quoted must be full & final. Nothing extra is payable other than quoted rates. Clause 10-CC shall not be applicable for this account.

#### **6.0 DAMAGES TO BSNL INSTALLATION:**

- 6.1 Any damage to the installation(s)/building during the maintenance period due to the carelessness on the part of maintenance staff shall be the responsibility of firm/contractor & shall be replaced/rectified by the firm without any extra cost.
- 6.2 Any accident or damage during maintenance will be the responsibility of the firm/contractor & the Department will not entertain any claim, compensation, penalty etc. on this account or on account of non observance of any other requirement of law relevant to his work.

#### 7.0 CURRENCY OF CONTRACT:

- 7.1 The currency of contract shall be **24 months**. The Department reserves the right to terminate the contract by giving show cause notice of one-month duration at any time during the currency of the contract.
- 7.2 The Department reserves the right to extend the contract for a maximum period of six months (three months at a time) at the same rates & conditions, without the consent of the firm and beyond this period with mutual consent.

#### 8.0 TERMINATION OF CONTRACT:

- 8.1 Right is reserved by BSNL for terminating the contract due to serious default. This includes major break down or accident or loss due to negligence on the part of firm, failure to attend breakdown in reasonable / prescribed time, disobedience and abandoning the site etc. In such a case, Full Performance Guarantee shall be forfeited to BSNL. The decision of Superintending Engineer (E) in this regard shall be final and binding.
- 8.2 Right is reserved by BSNL for closure of the contract at any time by giving one month's notice for reasons not attributed to the Contractor. The decision of Executive Engineer shall be final and binding on the contractor for closure of contract and for which BSNL shall not entertain any claim.

- 1. In case a contractor fails to comply with preventive/ periodical maintenance schedules, a penalty of 25% of one month's bill amount shall be imposed.
  - 2. In case of a major accident/loss on account of negligence on the part of the contractor, the contract shall be terminated and 10% of the estimated cost shall be recovered. Decision of Executive Engineer (E) shall be final and binding on the contractor.
  - 3. Notwithstanding BSNL also reserves the right to carryout scheduled mtce activity, if not done by the main firm, at his risk & cost.

#### **10.0 GENERAL CONDITIONS:**

- 10.1 The contractor has to keep all the equipments under operation & maintenance and site neat and clean to avoid any accident and or fire hazards.
- 10.2 Dates of weekly, monthly, biannual / annual tests / maintenance activity, (wherever applicable), shall be displayed / recoded in relevant columns.
- 10.3 Contractor shall have a round the clock communication landlline/ Mobile telephone number at Chennai. A complaint register shall be maintained as per annexure—III. Whenever any complaint is received, it shall be recorded and complaint no. shall be given to the complainee.
- 10.4 Disposal of complaint shall be recorded and monthly report shall be submitted to the SDE (E) concerned. 10.5 The Contractor will display on a board in AC Plant room important telephone numbers.
- 10.6 The contractor shall not sublet the work or part thereof. However, services of specialized agencies for specific work can be obtained.
- 10.7 The contractor agrees that he shall at all times indemnify BSNL against all claims for compensation under the provisions of any law for the time being in force or in respect of any person employed by it in carrying out the contract. Further, such staff has no right to claim employment in BSNL.
- 10.8 The Contractor will provide the maintenance personnel workers with necessary T & P, Testing & safety equipments.
- 10.9 Contractor has to observe all the labour rules and regulations in force & BSNL shall not be liable for any default
- 10.10 The agency has to supply details as per annexure. If of all workers likely to be engaged by him before start of work and get it approved by Engineer-in-charge.
- 10.11 BSNL reserves the right to carry out any work at the risk and cost of the contractor, if the agency fails to perform any duty as per the contract.
- 10.12 Firm is responsible to keep workable spares and consumables for due performance of the contract. For critical spare parts, firm shall have arrangement with dealers for prompt supply.
- 10.13 The material used/replaced by the firm for the work shall have same specification. Alternate Make shall be allowed in case of immediate non availability / obsoleteness.

In case of outdoor installations, the painting shall be with weather proof paint.
- 10.16 Firm shall ensure energy conservation by switching—on the air conditioner units /lights & fans etc only when required, wherever O & M is forming the scope of contract.
- 10.17 In case of Emergency, contractor and/or his authorized engineer or supervisor shall be available at site on short notice from Engineer-in- charge and make all efforts to make the situation normal at the earliest 11. DOCUMENTS TO BE MAINTAINED AT SITE/MAINTENANCE OFFICE

#### 12 TEST CHECK BY THE FIELD ENGINEERS:

12.1 For the purpose of assessing the quality of service rendered by the firm against the above contract, the EE, SDE & JTO shall carryout inspection & test checks of the service/work under the contract periodically.

12.2 During these test checks they shall record any deficiency in the work. As per the principle of sampling, if service during sample test check is not found to be satisfactory, then penalty shall be imposed on the contractor as per the penalty clause no. 9.

#### 13.0 Guarantee and Defect Liability

- 13.1 The guarantee for replaced components / equipments shall be valid for twelve months after successful commissioning. The contractor shall guarantee that all replaced components / equipments are free from any defects and also the equipments work with satisfactory performance and efficiency not less than the guaranteed values.
- 13.2 Any part found defective during Guarantee period shall be replaced free of cost by the contractor. The service of the contractor's personnel, if required during this period shall be made available free of cost to the BSNL.
- 13.3 In case the contractor fails to depute his representative to attend the fault within the time frame Page **29** of **45**

stipulated in various clauses or fails to cause remedial measure within reasonable time as decided during joint inspection, the BSNL may proceed to do so at the contractor's risk and expenses and without prejudice to any right of the BSNL to recover such expenses.

#### 14.0 ENERGY CONSERVATION

- 14.1 BSNL Electrical Wing, Chennai Telephones is committed to reduction in energy bills by the way of energy conservation over a year by 10%.
- 14.2 The contractors shall co-ordinate with the departmental SDEs / JTOs while conducting Energy auditing of the AC Plant under maintenance for effective Energy Conservation. The contractor shall facilitate energy conservation measures prescribed for the particular plant.
- 14.3 The contractors are responsible for display of Energy conservation slogan stickers at prominent locations in the area under maintenance.
- 14.4 Totally Burnt out motors shall not be repaired but replaced with higher efficiency motors of reputed make.
- 14.5 Energy efficiency of Package AC plants, shall be maintained within the benchmark value. The benchmark value shall be assigned by JTO(E)/SDE(E) after testing, with respect to the present conditions within 2 months from the date of handing over the services for maintenance. A 10% allowance shall be given for ageing while setting the benchmark itself. Energy efficiency test shall be done once in a month.by the contractor. Reduction in Energy efficiency below the benchmark value shall result in suitable penalty as per the penalty clause.

- 3. Check for abnormal heating of Electrical contacts and Motor starter.
- 4. Check for any vibration in Package units (or in the floor)/suction/discharge pressure gauge.
- 5. Check discharge and suction pressure.
- 6. Check for any obstruction in the return air.
- 7. Check HP/LP cutouts.
- 8. Check V-belt tension of blower Motor/ condenser motor.
- 9. Check for any frosting at cooling coil.
- 10. Check working of fresh air fan.
- 11.Ensure working of fresh air fan in combination with blower in winter nights so as to utilize the outside lower ambient.

#### **MONTHLY**

- 1. Micro filter cleaning.
- 2. Fresh air filter cleaning.
- 3. Check electrical contacts and tighten them.
- 4. Check for leakage of conditioned air.
- 5. Check of controls.

### Quarterly.

1. Check opening closing of volume control Damper, and supply Air Dampers. (March, June, Sept, Dec)

- 2. Check electrical contacts and tighten them if required.( March, June, Sept, Dec)
- 3. Lubrication of all bearing etc.(Jan, April, July, Oct)

#### **HALF YEARLY**

- 1. Earth testing......(April, Oct)
- 2. Meggering.....(April, Oct)
- 3. Inspection of pipe insulation / boxing) ...... (May & Nov)

#### **YEARLY**

1. Complete servicing of A/C pkg. plant before onset of summer ( i/c charge of compressor oil , de-scaling of all water lines , valves and condensers.)

#### **Testing**

Detailed Testing of the installation shall be done once in a year to find out capacity and efficiency of various equipment with respect to their rating. The testing procedure shall be same as adopted at the time of original testing (but without involving the T&D persons.)

### **PART IV: MATERIALS**

#### **SECTION 1: PAC PLANT:**

All the materials required for carrying out routine maintenance with the exception of following shall be arranged by the contractor at his own cost.

1. Replacement of complete AC pkg unit, Complete Condenser and main MV Panel, filters, Annunciation panel.

However Refrigerant lost during the operation, oil, fan belt, & filter shall be firm's responsibility.

NOTE: - The replacement of material shall be with the same rating and make as that of the original. However, in case of non-availability of a particular make, the Engineer-in-charge will approve the alternate make.
