

ADDENDUM

Section 4 Part A

20.1 Since the tender includes installation /de installation work of three different items viz

1. NGN equipment dismantling of Racks and Installation of Racks.
2. Installation /Dismantling of Battery sets.
3. Installation /Dismantling of Power Plants.

The Bidder can submit financial bids relevant to their area of expertise along with the relevant experience certificate as per the clause 4.2 of Section 1 Part -1(A).

However bids should be submitted for all the line items of particular item of work namely

1. NGN equipment dismantling of Racks and Installation of Racks. -SI No. 1 to 8
2. Installation /Dismantling of Battery sets – SI.No. 9 to 12
3. Installation /Dismantling of Power Plants – SI.No 13 to 15

SECTION-5 Part A

30. Restrictions under Rule 144(xi) of the General Financial Rules (GFRs) 2017, on grounds of Defence of India and National Security.

30.1 Bidder's from a country which shares a land border with India will not be eligible to participate in this tender, unless the bidder is registered with Department for Promotion of Industry and Internal Trade (DPIIT) under Order (Public procurement No. 1) issued by Ministry of Finance, Department of Expenditure in line with OM No. F.No.6/18/2019-PPD dt 23rd July, 2020 inserting Rule 144 (xi) in GFR 2017.

30.2 Any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.

30.3 "Bidder" (including the term 'tenderer', 'consultant', or 'service provider' in certain contexts) means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms or companies), every artificial juridical person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or office controlled by such person, participating in a procurement process.

30.4 "Bidder from a country which shares a land border with India" for the purpose of the Order means:-

- a. An entity incorporated, established or registered in such a country; or
- b. A subsidiary of an entity incorporated, established or registered in such a country; or

- c. An entity substantially controlled through entities incorporated, established or registered in such a country; or
- d. An entity whose beneficial owner is situated in such a country; or
- e. An Indian (or other) agent of such an entity; or
- f. A natural person who is a citizen of such a country; or
- g. A consortium or joint venture where any member of the consortium or joint venture falls under any of the above

30.5 The beneficial owner for the purpose of 30.4 above will be as under:

30.5.1. In case of a company or Limited Liability Partnership, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has a controlling ownership interest or who exercises control through other means.

a. "Controlling ownership interest" means ownership of or entitlement to more than twenty-five percent of shares or capital or profits of the company;

b. "Control" shall include the right to appoint majority of the directors or to control the management or policy decisions including by virtue of their shareholding or management rights or shareholders agreements or voting agreements;

30.5.2. In case of a partnership firm, the beneficial owner is the natural person(s) who, whether acting alone or together, or through one or more juridical person, has ownership of entitlement to more than fifteen percent of capital or profits of the partnership;

30.5.3. In case of unincorporated association or body of individuals, the beneficial owner is the natural person(s), who, whether acting alone or together, or through one or more juridical person, has ownership of or entitlement to more than fifteen percent of the property or capital or profits of such association or body of individuals;

30.5.4. Where no natural person is identified under 30.5.1 or 30.5.2 or 30.5.3 above, the beneficial owner is the relevant natural person who holds the position of senior managing official;

30.5.5. In case of a trust, the identification of beneficial owner(s) shall include identification of the author of the trust, the trustee, the beneficiaries with fifteen percent or more interest in the trust and any other natural person exercising ultimate effective control over the trust through a chain of control or ownership.

30.6 An agent is a person employed to do any act for another, or to represent another in dealings with third person.

30.7 The successful bidder shall not be allowed to sub-contract works to any contractor from a country which shares a land border with India unless such contractor is registered with the Competent Authority.

30.8 In respect of tenders, registration should be valid at the time of submission of bids and at the time of acceptance of bids.

30.9 Bidders not having a land border with India are to submit Annexure – I. Firms which do not submit Annexure – I will be considered as non-responsive and could be summarily rejected.

30.10 Bidders having a land border with India are to submit Annexure – II. Firms which do not submit Annexure – II will be considered as non-responsive and could be summarily rejected.
