- b) DD/ Banker's cheque /Bank Guarantee of a Scheduled Bank or Nationalized Bank/ State Bank guaranteed by Reserve Bank of India drawn in favour of "BSNL Chennai Telephones" and payable at Chennai. - 4. The EMD of all the unsuccessful tenderers shall be released on issue of award letter to the successful tenderer. This shall be done within one week of award letter.
- 5. Exemption from payment of security deposit by any other unit/ department shall not hold good for BSNL.
- 6. - 7. The bidding process will be accepted only through e-Tendering platform. As tenders are invited through e-Tendering process, physical copy of the tender document would **not be available for sale.** Contractor can upload documents in the form of JPG format, PDF format and any other format as permissible by the e- tendering portal.
- General conditions of contract for works in BHARAT SANCHAR NIGAM LIMITED (BSNL EW-8) are available on BSNL website <u>http://www.Chennai.bsnl.co.in</u> as well as in the Division Office.
- 9. For e-Tendering, BSNL has engaged e-portal maintained by NIC, New Delhi. The agency intending to participate in tendering process shall have to register with

<u>www.etenders.gov.in</u>, for details kindly visit website <u>www.etenders.gov.in</u>. The intending bidders must have Class-III digital signature to submit the bid.

- 10. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheet.
- 11. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in yellow colour and moment rate is entered, it turns green. In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" {Zero}.
- 12. Before e- tendering, the contractor shall inspect the site and fully acquaint himself about the condition with regard to accessibility of site and site nature and the extend of grounds, working condition, including stocking of materials, installation of T&P etc., and conditions affecting accommodation and movement of labour etc., required for the satisfactory execution of the contract. No claim whatsoever on such account shall be entertained by the BSNL in any circumstances.
- 13. The Bid can only be submitted after uploading the following scanned documents (all documents shall be self-attested) :
 - a) Documentary proof of satisfying eligibility conditions as above.
 - b) Copy of PAN card, valid GST registration, CA certificate for turnover, EPF Registration certificate, ESI registration Certificate
 - c) Demand draft of cost of tender documents.
 - d) EMD in prescribed form.
- 14. Originals of bank instruments such as DD or EMBG towards Tender Fee, EMD/ Bid Security respectively (if not submitted through e-payment mode), shall be submitted by bidder to O/o **Executive Engineer (E)**, **BSNL Electrical Division-I**, 2nd Floor, TE **Building,Kellys,Chennai-600010 on any date before or within 5 days of bid submission end date** failing which the tender bid (if already opened on basis of scanned copies uploaded in 1st electronic Envelope i.e. Technical Envelope, shall be rejected.
- 15. After submission of the bid online the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
- 16. While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.
- 17. The bid submitted shall become invalid and cost of bid & e-tender processing fees shall not be refunded if:
 - (i) The bidder is found ineligible.
 - (ii) The bidder does not upload all the documents as per check list.
- 18. Performance Guarantee (PG): -The Firm shall have to furnish Performance guarantee@ 5% of the contract value of the individual contract within two weeks of the date of

issue of award letter in the form of Bank guarantee on a Nationalized/Scheduled bank in standard format (Annexure-II)/ CDR/ FDR/ DD. This period can be further extended by the Engineer-in-Charge up to a maximum period of two weeks on written request of contractor.

This performance guarantee shall be submitted to the Electrical Division in the name of concerned Accounts officer of the SSA where work is to be executed and shall be valid for 12months from the date of actual completion of individual work.

- 19. Security deposit: -A sum @ 10% of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum will amount to security deposit of 10% (i/c 5% PBG) of actual work done. This Security Deposit shall be released after an observation period of 12 months after the date of completion of work.
- 20. The acceptance of tender will rest with the SE (E) BSNL EC-II, Chennai who does not bind himself to accept the lowest tender or any other tender & reserves to himself the Authority to reject lowest or all the tenders received without assigning any reason. All tenders in which any of the prescribed conditions are not fulfilled or incomplete in any respect are liable to be rejected. Tenders with any condition including that of conditional rebates shall be rejected forthwith summarily.
- 21. Canvassing in connection with tender is strictly prohibited & the tenders submitted by the contractors who resort to canvassing will be liable for rejection.
- 22. The BSNL reserves itself the right of accepting the whole or any part of the tender & the tenderer shall be bound to perform the same at the rates quoted.
- 23. The tenderer should give a certificate that none of his/her relative is employed in BSNL units. In case of proprietorship firm, certificate will be given by the proprietor & for partnership firm certificate will be given by all the Directors of the company.
- 24. Near relatives of all BSNL employees either directly recruited or on deputation are prohibited from participation in tenders and execution of works in the different units of BSNL. The near relatives for this purpose are defined as:
 - a) Members of a Hindu Undivided family.
 - b) They are husband and wife.
 - c) The one is related to the other in the manner as father, mother, son(s) & son' wife (daughter-in-law), Daughter(s) & daughter's husband (son-in-law), brother(s) & brother's wife, sister(s) & sister's husband (brother -in-law).
- 25. The company or firm or any other person is not permitted to tender for works in BSNL Unit in which his near relative (s) is (are) posted. The unit is defined as SSA/ Circle/ Chief Engineer/ Chief Archt./ Corporate office for non-executive employees and all SSA in a circle including circle office/Chief Eng./ Chief Archt./ Corporate office for executive employees (including those called as Gazetted officers at present). The tenderer should give a certificate that none of his/her such near relative is working in the units as defined above where he is going to apply for tender/ work, for proprietorship, partnership firms & limited company certificate shall be given by the authorized signatory of the firm. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and performance guarantee will be forfeited at any stage whenever it is so noticed. BSNL will not pay any damages to the company or firm or the concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.

- 26. No employee in BSNL/ Govt. of India is allowed to work as a contractor for a period of two years of his retirement from service without the prior permission. The contract is liable to be cancelled if either the contractor or any of his employees is found at any time to be such a person who had not obtained the permission as aforesaid before submission of tender and engagement in the contractor's service.
- 27. The tender for the works shall not be witnessed by the contractor who himself/themselves has/ have tendered or who may and has/have tender for the same work. Failure to observe this condition would render tenders of the contractors tendering as witnessing the tender is/are liable for summarily rejection.
- 28. It will be obligatory on the part of the tenderer to sign each page of the Schedule of work and the tender documents for all the component parts and after the work is awarded he will have to enter into a separate agreement with the officer concerned.
- 29. Any tender not submitted in proper manner or not as per the directions of ONLINE submission, BSNL will be at liberty to take such action as it may deem fit without any reference to the tenderer.
- 30. The tenders for the work shall remain open for acceptance for a period of 90 days from the date of opening of the tenders. If any tenderer withdraws his tender before the said period or makes any modification in the terms and conditions of the tender which is not acceptable to the BSNL shall, without prejudice to any other right of remedy be at liberty to forfeit 50% (fifty percent only) of the said earnest money absolutely.
- 31. Extension of validity: In case, where the letter of award of work cannot be placed within the validity period of the tender, the BSNL can request all tenderers to extend the validity of their respective tenders by a reasonable period. While BSNL can make the request for extension, the tenderer is free to either extend the validity or refuse the request to extend the validity.
- 32. The contractor should read the tender documents carefully before submitting the tender. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- 33. Conditional tenders or tender with conditional rebates shall be summarily rejected.
- 34. Agreement shall be drawn with the successful Tenderer on prescribed Form No. BSNL EW-6/8, which is available on BSNL website <u>http://www.Chennai.bsnl.co.in</u>. Tenderer shall quote his rates as per various terms and conditions of the said form.
- 35. In case the eligibility credentials are found to be fake or falsified at any stage i.e. before award of work or during execution of the work or after completion of the work, the contractor will be debarred from tendering in BSNL for three years including any other action under the contract or existing law.
- 36. This Notice Inviting Tender shall form part of the Contract document. The successful tenderer/Contractor on acceptance of his tender by the accepting authority shall

within 15 days from the stipulated date of start of the work, formally sign the contract consisting of:

- a) The Notice Inviting Tender, all the documents including additional conditions, specifications and drawings, if any, forming part of the tender and as issued at the time of invitation of tender and acceptance thereof together with any correspondence leading thereto
- b) Standard EW-8 form.
- 37. EPF PROVISIONS: The agency has to comply with the provision of EPF and miscellaneous provisions Act 1952 and employees Provident Fund scheme-1952 as amended up to date in respect of labours /employees engaged by them for this work. Any consequences arising due to non-complying of provisions as specified above shall be of the sole responsibility of the firm only. The agency shall give an undertaking to this effect as per the prescribed proforma (Annexure IV).
- 38. The site for the work shall be made available in parts.
- 39. If any terms and conditions mentioned in this NIT document are in contravention to BSNL EW6/EW 8 General Conditions of Contract, the terms and conditions mentioned in this document shall prevail.

GENERAL CONDITIONS

1. Scope of work:

- (i) Attending to the faults in the existing lift as per the schedule of work/ Quantities to restore the lift to working condition.[Part A- Supply & ITC]
- (ii) After successful completion of (i) above, carrying out the comprehensive AMC of the lift for the prescribed period as per the schedule of work/quantities. [Part B: AMC]

2. Methodology:

- i. It is presumed that contractor shall undertake the stated responsibilities only through qualified and experienced staff.
- ii. AMC services shall be provided round the clock round the year even on holidays. For preventive and break down maintenance the extra specialized labour shall be deployed based on manufacturers recommendations and as per the requirement to bring system to healthy condition with minimum equipment downtime. Notwithstanding the above it is the responsibility of the agency to provide required manpower to attend the complaints within the time frame specified as the tender is of comprehensive nature.

The workforce shall have knowledge of first aid i/c electrical shock treatment, attend to fire situation and other emergencies likely to encounter for such works.

3. TOOLS & PLANTS

All tools and plants required for carrying out various tasks relevant to maintenance have to be arranged by agency at its own cost.

4. **GENERAL**

- i. The workers engaged by firm should maintain proper discipline and good behaviour with occupants.

- vi. Agency has to observe all the labour rules and regulations in force and indemnify BSNL against any claims whatsoever, either from this clause or any other clause in the contract.
- vii. Firm shall issue ID card to their workforce whenever they enter premises for bonafide work. Nobody shall be allowed entry without work and nobody will be allowed overnight stay without work.
- viii. Dismantled materials shall be returned to the BSNL except those items for which the replacement is supplied by the agency.

- ix. The BSNL reserves the right to carry out any work at the risk and cost of the agency, if the agency fails to perform any duty as per the contract.
- x. The tenderer must obtain himself at his own expense all the information necessary for the purpose of tendering.
- xi. The contractor or his representative should Inspect the site and acquaint him-self with all the local conditions, means of access to work and nature of work etc. No claims shall be entertained on these accounts.
- xii. The contractor shall not sublet the work or part thereof. However, services of specialized agencies for specific work must be obtained e.g. servicing of EA sets must be got done thorough authorized service dealers only. Regular servicing and maintenance of ACBs/ HT panel/ Transformers/ relays etc., shall be carried out through the specialized firms/persons only or by firms having required and sufficient experience to handle and service these items. Credentials of the firms may be furnished for verification.
- xiii. While working inside the premises the agency shall be responsible to provide necessities to them as per labour law. However existing facilities like water, toilet and power for bona fide use shall be provided by BSNL. Any workforce not required for carrying out task shall not be permitted to stay in the premises.
- xiv. Arranging Furniture and stationary to carry out the work shall be the responsibility of the firm.
- xv. The BSNL reserves the right to terminate the contract by giving show cause notice of one-month duration at any time during the currency of the contract without assigning any reason.
- xvi. The BSNL reserves the right to extend the contract for a maximum period of six months at the same rate and conditions.

6. Terms of Payment:

Part-A:- FOR SUPPLY & ITC:

- a) 70% Against supply of material (after successful inspection of Engineer-in-charge)
- b) 30% Against successful ITC of Lift.

Part-B:- FOR AMC:

a) Quarterly payment subject to production of invoice and all relevant and required documents specified elsewhere in the conditions/ specification (after successful inspection of Engineer-in-charge)

<u>Note:</u>

- i. In case of unsatisfactory performance during this period 10 (Ten) percent penalty of the Bill amount shall be imposed and any deficiency in labour or performance of servicing / maintenance /repair work shall be penalized. Decision of engineer-in-charge shall be final and binding.
- ii. In case of a major accident/loss on account of negligence on the part of the contractor, the engineer-in-charge may cause the same to be made good by other workmen & deduct the expense from any sums that may be due, or at any time thereafter may become due to the contractor, or from performance guarantee & security deposit or the proceeds of sale there of or of a sufficient portion thereof. The performance guarantee & security deposit of the contractor shall not be refunded before the expiry of twelve months after the issue of the certificate final or otherwise, of completion of work, or till the final bill has been prepared and passed whichever is later.
- iii. In case of breakdown calls, if agency fails to send / arrange people within 24 hrs, then department is at liberty to attend to breakdown and the expenditure incurred will be deducted from the bills due to the agency.

7. Period of Contract:

Part-A:- Supply & ITC:- Two Months

Part-B:-Annual Comprehensive Maintenance:- 36 Months

- 8. **Near relatives** of all BSNL employees either directly recruited or on deputation are prohibited from participation in tenders and execution of works in the different units of BSNL. The near relatives for this purpose are defined as:
 - a) Members of a Hindu Undivided family.
 - b) They are husband and wife.
 - c) The one is related to the other in the manner as father, mother, son(s) & son' wife(daughter-in-law), Daughter(s) & daughter's husband (son-in-law), brother(s) & brother's wife, sister(s) & sister's husband (brother -in-law)

The company or firm or any other person is not permitted to tender for works in BSNL Unit in which his near relative (s) is (are) posted. The unit is defined as SSA/ Circle/ Chief Engineer/ Chief Archt./ Corporate office for non-executive employees and all SSA in a circle including circle office/Chief Eng./ Chief Archt./ Corporate office for executive employees (including those called as Gazetted officers at present). The tenderer should give a certificate that none of his/her such near relative is working in the units as defined above where he is going to apply for tender/ work, for proprietorship, partnership firms & limited company certificate shall be given by the authorized signatory of the firm. Any breach of these conditions by the company or firm or any other person, the tender/work will be cancelled and earnest money/performance guarantee will be forfeited at any stage whenever it is so noticed. BSNL

will not pay any damages to the company or firm or the concerned person. The company or firm or the person will also be debarred for further participation in the concerned unit.

9. Earnest Money

i. Value

The amount of earnest money to be deposited with each tender is 2% of the estimated cost put to the tender subject to a maximum of Rs.2 crores. Earnest money will be acceptable in the form of CDR/FDR/DD/BG of a scheduled bank of nationalized bank/ state bank guaranteed by Reserve Bank of India.

ii. Validity Period

The validity period of the Earnest Money Deposit is kept 30 days beyond the tender validity e.g. 90 + 30 = 120 days, since the tender validity period is 90 days.

iii. **Extension of Validity**

In case, where the letter of award of work cannot be placed within the validity period of the tender, the BSNL can request all tenderers to extend the validity of their respective tenders and the Earnest Money deposit by a reasonable period. In such cases, extension of validity of Earnest Money deposit by 30 days beyond the extended validity date of tender should also be asked for. While BSNL can make the request for extension, the tenderer is free to either extend the validity or refuse the request to extend the Validity.

10. **Performance Guarantee**

The contractor is required to furnish performance guarantee for an amount equal to 5% of the contract value in the form of bank guarantee (of a Nationalized/ Scheduled Bank in a standard format)/ CDR/ FDR/ DD within two weeks from the date of issue of award letter. The validity period of the performance security in the form of performance bank guarantee shall be one year from the date of actual completion of work.

11. Security Deposit

In addition to performance guarantee stated above, a sum @ 10% of the gross amount of the bill shall be deducted from each running bill of the contractor till the sum, will amount to security deposit of 10% of the value of work done including 5% Performance Guarantee.

12. Increase/ Decrease of tendered quantity

BSNL will have the right to increase or decrease up to 50% of the quantity of goods and services specified in the schedule of items without any change in the unit price or other terms and conditions at the time of award of contract. In exceptional and unavoidable cases BSNL can increase the quantity of goods and services beyond 50% of the tendered quantity without any change in tendered and accepted unit price and also other terms and conditions as applicable at the time of award of contract.

Note: The above item is applicable only in case of supply contracts items but not for comprehensive maintenance contracts.

13. **Completion of work**

The contract period for this work is 2 (Two) months (Part-A:-Supply and ITC) and the same shall be completed by covering all aspects as mentioned in the "General Specification".

For AMC the contract period is 36 months.

14. **Extension of time**

If the contractor shall desire an extension of time for completion of any pending repair work prior to handing over the site / sites to the new firm / contractor or back to BSNL on the grounds of his having been unavoidably hindered in its execution or on any other ground, he shall apply in writing to the Engineer – in –charge within 10 days of intimation to handover the site giving reasons on account of which he desires such extension as aforesaid, and the Engineer – in – charge shall, if in his opinion reasonable grounds to be shown therefore, authorize such provisional extension of time, if any, as in his opinion be necessary or proper.

15. **Variation** in Excise Duty – NOT APPLICABLE

- In case of statutory variation in Excise Duty in respect of EA sets only within the stipulated date of completion of individual agreement, the same shall be paid or recovered as per the actual against documentary proof. However, beyond this period the department will take advantage of any duty reduction but will not pay extra on account of duty increase.
- ii. Price adjustment provision on account of change in Excise duty shall not apply in respect of equipment/component of equipment/materials other than EA sets.

Note : The above item is applicable only in case of supply contracts items but not for comprehensive Mtce contracts.

16. **The** Department reserves the right to accept the quantities in full or in parts.

- a) Tendered rates inclusive of taxes and levies payable under the respective statutes. However, pursuant to the Constitution (Forty Six Amendment) Act 1982, if any further tax or levy is imposed by the Statute after the date of receipt of tenders and the contractor(s) thereupon necessarily and properly pays taxes or levies the contractor(s) shall be reimbursed the amount also paid provided such payment if any is not in the opinion of SE (whose decision shall be final and binding) attributable to delay in execution of work within the control of the contractor(s).
- b) The contractor(s) shall keep necessary books of accounts and other documents for the purpose of this condition as may be necessary and shall allow inspection of the same by a duly authorized representative of Government and shall furnish such other information/documents as the Engineer-in-charge may require.
- c) The contractor(s) shall within a period of 30 days of imposition of any further tax or levy pursuant to the Constitution (Fourty Six Amendment) Act 1982 give a written notice thereof to the Engineer-in-charge that the same is given pursuant to this condition together with all necessary information relating thereto.

NOTE : No additional condition whatsoever will be accepted for turnover tax. In case of additional conditions for the payment of such taxes by the contractor the tender may be liable to be summarily rejected by the accepting authority. No conditional offer shall be entertained and rejected. (Standing order No.258)

17. **BID PRICES, TAXES AND DUTIES**

The bidder shall give the total composite price inclusive of all Central and State's Levies & Taxes i.e. GST (applicable CGST/ SGST/ IGST) material, labour etc., except octroi/ Entry Taxes. Octroi/ Entry Taxes will be paid extra, as per actual, wherever applicable on production of proof of payment/ relevant invoices/ documents.

The price approved by BSNL for procurement will be inclusive of levies and taxes, Packing, Forwarding, Freight and Insurance etc. except octroi / Entry Taxes.

- (a) The total composite price shall comprise of unit price and all other components of price need to be individually indicated/ quoted against the goods/ material/ service, it proposes to supply under the contract in the following manner :
 - (i) The Basic Unit price (Ex-Factory Price) of the goods/ services/ materials, GST payable by the supplier shall be quoted separately.
 - (ii) The liability to pay all taxes, levies etc. shall be of contractor and BSNL will not entertain any claim whatsoever in this respect.
- (b) Input Tax credit to BSNL(wherever applicable) :
 - (i) The firm shall furnish correct HSN/ SAC codes in GST challans/ invoices for availing Input Tax credit by BSNL
 - (ii) Vendors should furnish the correct taxes and cess under GST tariff head in the price Schedule. If the input tax credit for the Duties and Taxes under GST ACT 2017 is found to be not admissible at any stage subsequently owing to wrong furnishing of tariff Head, then the vendors will be liable to refund such non-admissible amount, if already paid along with penalty if charged by the concerned authority.
 - (iii) In case where the input tax credit is not offered by the vendor as per the quotes indicated in the price schedules and subsequently at any stage it is found that input tax credit is admissible as per GST ACT 2017 then the venders will be liable to refund the amount equivalent to such Duties & Taxes if already paid to them. However, the purchaser may allow the supplier to submit necessary documents in this regard which may enable the purchaser to avail the input tax credit provided such credit is still available for the amount so paid as per GST ACT 2017.
 - (iv) The purchaser reserves the right to ask the bidders to submit documentary proof confirming the correct Tariff Head from the GST authority where the tariff head furnished against the particular tendered item by different bidders differs from each other or the same is found apparently not furnished in accordance with GST ACT.
 - (v) If the supplier fails to furnish necessary supporting documents for input tax credit the amount pertaining to such duties/taxes will be deducted from the payment due to the firm.
 - (vi) Invoice should clearly indicate name, address and GSTIN of the supplier, date, name address and GSTIN of the recipient, Place of supply along with name of state, HSN

code of Goods or Service Accounting code (SAC), breakup details of composite price i.e. basic unit price (Ex-Factory price) of the goods/ services/ materials, etc., rate of GST such as CGST/ SGST/ IGST or any other duties and taxes.

(vii) In case of any statutory variation in regard to Input tax credits, within the currency of individual agreement including extension of time period, the same shall be admissible as per actual Input tax credits only, subject to the condition that the reason for such extension of time period is not attributable to the agency.

18. **EVALUATION OF BIDS**

The evaluation and comparison of responsive bids shall be done on the basis of net cost to BSNL on the prices of all items included in schedule of work offered inclusive of packing, forwarding, freight and insurance charges but excluding Input tax credit/ GST. The Octroi/ Entry Taxes are not to be included in the composite price and hence the same will not be considered for the purpose of evaluation and comparison of responsive bids. However, Octroi/ Entry Taxes will be paid extra, as per actual, wherever applicable, on production of proof of payment/ relevant invoices/ documents.

19. Miscellaneous

The firm must meet all statutory obligations towards the labours employed at its own cost.

20. **TERMINATION OF CONTRACT ON DEATH OF CONTRACTOR:**

Without prejudice of any of the rights or remedies under this contract, if the contractor dies, the Engineer in charge on behalf of the BNSL shall have the option of terminating the contract and the agreement will be closed immediately, the due payments will be issued to the legal heirs of the agency after producing the proof of the same along with death certificate of the agency.

21. INDULGING <u>OF CONTRACTOR IN CRIMINAL/ANTISOCIAL ACTIVITIES AND CASES</u> <u>UNDER INVESTIGATION/CHARGE SHEETED BY CBI OR ANY OTHER GOVERNMENT</u> <u>AGENCIES ETC.</u>:

If the CBI/ Independent External Monitor (IEM)/ Income tax / GST/ Central Exercise/ Custom Departments recommends such a course-Action will be taken as per the directions of CBI or concerned department.

22. **VARIATION IN GST:**

In case of any statutory variation in regard to Input tax credit, within the currency of individual agreement including extension of time period, the same shall be admissible as per actual Input tax credit only, subject to the condition that the reason for such extension of time period is not attributable to the agency.

TECHNCIAL SPECIFICATIONS FOR THE WORK

FOR PART A: SUPPLY & ITC

- 1. The work shall be done as per current CPWD General specification for Electrical work Part – I Internal, Part –II External, Part – III lifts & Escalators, IS & National Building/electrical Code/ THE TAMIL NADU LIFTS ACT, 1997& NIT conditions as amended from the time-to-time and Indian Electricity rules amended upto date. [Important CPWD specifications/publications are available in website http://cpwd.gov.in/Publications.htm for reference & also available with authorized bookshops]
- 2. Material for door replacement shall be stainless steel Doors shall be scratch resistant and corrosion proof. Doors shall be as per CPWD specifications.
- 3. Variable Voltage Variable Frequency Drive (VVVF) shall have all the features as per the CPWD specifications and of superior industry standards. The drive shall be energy efficient. Since the drive is to be replaced for the existing lifts, firm shall ensure that there is no compatibility issues. After replacement, lift shall not face frequent failures, levelling issues, in which case the firm shall replace the controller free of cost. It is expected that the controller so supplied shall have a shelf life of atleast 7 years and that the components used are generally available in the market. Codes/passwords, if any, related to the drive shall be furnished to the engineer-in-charge. User shall be trained on the usage and minor nature of fault attending in the controller.
- 4. Compatible ARD device shall be fitted to the lift which shall fulfil CPWD Standards. Batteries provided in ARD device shall be BSNL Approved make. Batteries are expected to have atleast 3 years of service warranty.
- 5. All safety features shall be made functional.
- 6. All required works shall be carried out, so as to make the lift fit for usage and that the lift pass the tests by electrical inspector for issuance of licence.
- 7. Firm shall ensure availability of Floor annunciator, Invertor for Emergency Light and Alarm, Overload warning device, Full height Light curtain, VVVF drive for Door operator, Surface mounted Push button stations etc.,
- 8. The firm shall employ industry latest practices for installation including adherence to safety and use of safety devices and ensure suitable instructions are displayed at the place where the work is going on, to avoid any accidents
- 9. Door opening shall always be barricaded during the course of carrying out works.
- 10. The Contractor at his own risk and cost shall arrange all necessary Tools and Plants.
- 11. The earthing shall be done only in the presence of Engineer-in-charge or his authorized representative.
- 12. The work shall be supervised by qualified supervisor.
- 13. The work shall be started after obtaining the layout from the Engineering-in-charge or his duly authorized representative at the site of work.
- 14. Sample of all materials accessories shall be got approved from the Engineer-in-charge before using the same for the work.

- 15. Cable laying shall be as per CPWD specifications and cable shall be as per IS amended from time to time.
- 16. The contractor shall impart training to the operator deputed by the department for operation and attending the minor fault free of cost.
- 17. Testing and completion reports: The contractor after successful installation should test all the equipment and electrical installations/panels etc., including earthing and cabling and submit a self-certification to the BSNL that the work has been completed successfully as per specifications drawings and other terms and conditions of agreement and tender document. The following details should be submitted along with the above certificate.
 - i. Earth Resistance (Value in Ohms)
 - ii. Cable Insulation (Value in Meg-Ohms)
 - iii. Date of Installation.
 - iv. Completion plan and wiring diagram.

 - vii. Switches, MCBs, Isolators, fuses type/ capacity/ make.

The Engineer in charge or his representative shall have the right to inspect and test the Lift Installations as per prescribed test schedules for their conformity to the specifications. Where the Engineer in charge decides to conduct such tests on sites or the premises, all reasonable facilities and assistance like testing instruments and other test gadgets including access to drawings and other details shall be furnished to the Engineer In Charge. Should any inspected or tested component fail to conform the specifications, the BSNL may reject them and the agency shall either replace the components make all alterations necessary reiected or to meet the specifications/requirements free of cost to the BSNL.

PART B: AMC OF LIFTS

The Contractor is referred to here as 'Contractor' or 'Agency' or 'Firm' and Bharat Sanchar Nigam Limited as BSNL represented by Executive Engineer (E), Electrical Division-I, Chennai and his representatives.

The original manufacturer is M/s Supriya Elevators, Chennai

- 1. The prices shall be firm for the contract period. The contract can be extended up to six
- 2. The firm will use trained and appropriately skilled personnel, which it directly employs and/ or supervises. They will be qualified to keep the equipment properly adjusted and they will use all reasonable care to maintain the equipment in efficient, reliable and safe operating condition.
- 3. The firm will in accordance with the terms hereof, regularly examine, lubricate and adjust the equipment and generally carry out planned maintenance in a systematic and controlled manner using firm's developed techniques and expertise.
- 4. The firm will, repair or replace any parts detailed in the following section, which, are defective.

5.

- a) Examine periodically all wire ropes and chains (where fitted) as often as required to maintain an adequate factor of safety, to equalize the tension on all hoisting ropes, repair or replace conductor cables and hoist way and machine room elevator wiring.
- b) Furnish lubricants compounded to original manufacturer's stringent specifications.
- c) Examine periodically all safety devices and governors and make all customary safety tests.
- d) Systematically examine and adjust the following components:
 - Machine, worm gear, thrust bearings, drive sheave, drive sheave bearings, break contact, lining and components, Motor, motor generator, motor windings, rotating elements, commutator, brushes, brush holders, bearings, coils, resistance for operating and motor circuits, magnet frames& other mechanical parts. Controller, selector, leveling devices, cams, relays, solid state components eg. PCB's, transducers, resistors, condensers, power amplifiers, transformers, contacts, leads, dashpots, timing devices, steel selector tapes and mechanical and electrical driving equipment. Servicing & maintaining of ARD and amplifiers/ sills. Governor, governor sheave, shaft assembly, bearings, contacts and governor jaws.car and hall mechanical buttons, car and hall position indicators, hall lanterns, car direction indicators and all other car and landing signal fixtures as installed by the original manufacturer, Deflector or secondary sheave, bearings, car and counterweight guide and buffers, top and bottom limit switches, governor tensions sheave assembly, compensating sheave Assembly, car, counterweight and counterweight guide shoes including rollers or Gibbs, Interlocks on hoist way door, hoist way door hangers, guides, automatic power operated door operator, car door hanger, car door contact, safety shoe, load weighing equipment, car frame, car safety mechanism and platform. Emergency lights &alarm, ARD, infrared device etc.

- 6. The firm will where applicable, maintain the performance characteristics of the Equipment as originally designed and installed by the original manufacturer or as amended by mutual written agreement between the BSNL and firm.
- 7. The firm will give priority in its service, repair and manufacturing facilities to restoring the Equipment to normal service.
- 8. The firm will maintain the engineering wiring diagram and the same will be used by examiners 'or' authorized firm's representatives.
- 9. The firm will maintain a reasonable supply of genuine spare lending and replacement parts in its service depot.
- 10. All parts not excluded from the contract, will be furnished by firm on an exchange basis under which replaced parts become the property of firm.
- 11. All work and services provided for in this agreement are to be performed during normal working hours on normal working days.
- 12. The BSNL will allow firm employees free and unhindered access to the Equipment, and the landings, lobbies and machine room associated therewith and all areas mentioned therein.
- 13. The BSNL will report details of unsatisfactory running or irregular performance of the Equipment.

14. **EXCLUSIONS:** Only following items shall not be included in this contract. **TOTAL REPLACEMENT OF LIFT**

- 15. Firm will assign a representative to BSNL account who will periodically visit the building and will be available for consultation in any matter relegating to the maintenance of the elevators. Firm's service representative will be available to discuss with the BSNL, the BSNL elevator needs in the areas of modernization and proper use and care of the elevators.
- 16. The agency is responsible for:
 - a) Maintenance of lifts without fail during the AMC period
 - b) Identifying the fault in advance for operation of lift without stop.
 - c) Attending the fault within 24 hours of reporting through phone/ mail/ letter etc.,
 - d) Supervising and for sending adequate qualified/ authorized staff for maintenance work and for ensuring smooth functioning.
- 17. All materials required for maintenance should be supplied immediately. The agency should maintain logbook for receipt and usage of the material, no material will be supplied by the BSNL on any account. Rates quoted shall be inclusive of the cost of logbook.
- 18. The complaint register/ Work logbook should be maintained as per the Instructions of the Engineer-in- charge. Cost of logbook shall be included in the rate quoted.
- 19. The tools required for the general maintenance should be supplied by the contractor.
- 20. Damage to any installation of the BSNL due to the negligence of the agency's personnel shall be made good at the risk & cost of the agency.
- 21. In case any person leaving the organization or agency, the agency has to intimate well in advance for not giving any responsibility to that person.

- 22. The agency shall be responsible for the character and conduct of the staff employed. If any person found not satisfactory by the BSNL, he/she has to be removed from the site immediately and substitute must be posted.
- 23. The contract can be terminated by the BSNL without assigning any reason with onemonth prior notice.
- 24. The agency's personnel shall in no way disturb the working/ functioning of the personnel of the BSNL, inside the premises.
- 25. Identity cards issued by the agency and counter signed by the Engineer-in-charge shall be always available with the personnel entering the premises.
- 26. If any Lift is stopped from functioning beyond 3 (Three) days continuously excluding Sundays and Holidays due to non-attending or non-replacement of required spare parts, 'or' not due to force majure conditions, Rs. 1000/- per day recovery shall be made for the downtime period beyond 3 days. The decision of Engineer-in-charge is final and binding.
- 27. If the agency commits breach of terms and conditions of contract, the Engineer-incharge shall be at liberty to cancel the contract/ work order.
- 28. The agency shall display prominently its:
 - 1) Address
 - 2) Contact persons.
 - 3) Contact numbers.
 - a) In the lift machine room.
 - b) In the maintenance office at site with a copy to the Engineer-in- charge.
- 29. In case of disputes the same shall be referred the sole Arbitration of the person appointed by the Sr. Chief Engineer (E), BSNL Electrical Zone, Tamilnadu/ Administrative head of Electrical Wing at the time of such appointment. As per the Arbitration conciliation Act. 1996 amended upto date it will be no objection to any such appointment that the arbitrator so appointed is a Government servant or is an employee of the BSNL.
- 30. The pro-rate payment shall be made on quarterly basis or after longer periods, if firm so desires.
- 31. The Firm may quote the rate for operation of the lift if required on special days separately.

Note:

- A. In case of unsatisfactory performance during this period one percent penalty of the bill amount shall be imposed.
- B. For repeated unsatisfactory performance during the contract period penalty upto 5% of the bill amount shall be imposed. Decision of Executive Engineer [E] shall be final on this account.
- C. In case of a major accident/loss on account of negligence on the part of the contractor, the contract shall be terminated and 10% of the tendered cost shall be recovered.
- 32. The contractor shall keep Lift including associated electrical connection and accessories in clean and healthy working condition. All the parts of the Lift and including the outgoing termination of supply from the Lift panel is under the scope of maintenance
- 33. The contractor shall carry out maintenance tasks periodically as mentioned in the maintenance schedule and maintain the register and service report. The same shall be made available for inspection as and when required.
- 34. In order to avoid major failures, the maintenance contractor is to attend minor faults then and there.
- 35. Proper workings of the ARD including battery may be ensured for operating efficiency.
- 36. The Lift and accessories and the site shall be maintained neat and clean, and check the safety norms for proper working to avoid accidents and fire hazards.

37. Complaint Register

- 1. A complaint register as per Annexure shall be kept up to date by the firm and the same shall be available for checking & verification.
- 2. The complaint register shall be maintained in Sub Division and entry shall be made in this register as and when the complaint is reported from the end users. If JTO is not available in the office, other officials whoever available in the office should record the complaint in the register. It shall be the responsibility of the firm to verify the details of complaint & take corrective action.

38. <u>PENALTY CLAUSE</u>

- 1. Any damage to the installation(s)/building during the maintenance period due to the carelessness on the part of maintenance staff shall be the responsibility of firm & be replaced /rectified without any extra cost
- Any accident or damage during installation/ maintenance will be the responsibility of the agency & BSNL will not entertain any claim, compensation, penalty etc on this account or on account of non-observance of law to his work
- 3. If the agency fails to rectify any fault within 24 hours, the BSNL reserves the right to carry out any work at the risk and cost of the agency. In case the fault is of emergency nature which may affect the normal functioning of services and the firm fails to take immediate necessary action, the work shall be carried out at the risk and cost of the firm without giving any notice. The decision of EE (E) shall be final.
- 4. In case of major accident/loss on account of negligence on part of the contractor, the contract shall be terminated and 10% (ten percent) of the tendered amount shall be recovered.
- 5 It is incumbent upon the service provider that the lift is always operational and that the service provider does all periodical checks/services in time, so that the down time is minimised. However If the down time of any Lift exceeds one day in case of minor repairs from the time of complaint from exchange authorities or SDE(E) or JTO(E), the firm will be penalized @ Rs.250/- per day .This excludes major faults in Lift for which a maximum period of 3 days is allowed.

The following items will be considered as major repairs:-

- a. Rewinding of motors
- b. Replacement of Rope
- c. Armature Replacement
- d. Replacement of guide shoes for the car and counter weight.

The maximum penalty in any case shall **not exceed 1%** of the contract value per lift. In normal case of continued under/non-performance due to which down time of the lift per month is more than 5 days, then BSNL reserves the right to get the lift serviced/faults attended by engaging other agency.

39. **TOOLS &** PLANTS:

All tools and plants required for carrying out various tasks relevant to the work have to be arranged by the agency at its own cost.

40. **<u>TERMINATION CLAUSE</u>** :

- Right is reserved by BSNL for terminating the contract due to serious default. This includes major breakdown or accident or loss due to negligence on the part of the firm, failure to attend breakdown, disobedience and abandoning the site etc. In such a case, 3% performance guarantee shall be forfeited to BSNL. The decision of Superintending Engineer (E) in this regard shall be final and binding.
- Right is reserved by BSNL for closure of the contract at any time by giving one month's notice for reasons not attributed to the contractor. The decision of Executive Engineer(E) shall be final and binding on the contractor for closure of contract and for which BSNL shall not entertain any claim.

iii. Adherence to Tamilnadu Lifts Act'1997 & Renewal of License

It shall be the sole responsibility of the tenderer to maintain the Lift and its installation during the warranty period in accordance with the requirement laid down in The Tamilnadu Lifts Act'1997, read alongwith all the amendments till date

41. Maintenance schedule to be followed

- 1. The lift should be serviced periodically and shall use all care and maintain the lifts for safe and proper working condition and for safe operation.
- 2. Periodical maintenance shall be carried out as per manufacturers/standard specifications/ maintenance schedule.
- 3. Servicing work should be carried out as per the convenience of staff of the building
- 4. The agency should attend all break down calls
- 5. All defective components shall be replaced with original make which shall be got approved by SDE(E) for which no extra payment should be made
- 6. If any delay occurs in rectifying the faults/replacement of defective components/ rectifying the faults, suitable penalty will be imposed which will be under the purview of Engineer-in-charge
- 7. It is the firm's responsibility of proper and uninterrupted working of the lift.
- 8. Maintenance related with Electrical supply system to Lifts, El & Fans in lift shaftand painting is not included within the scope of the work.

- m) Checking car telephone and readiness of emergency operations
- n) Cleaning of door guide shoe grooves of sill
- o) Checking fireman switch
- p) Check shaft light and replace bulbs if required
- q) Cleaning car light and fan
- r) Checking of Main rope or OSG rope
- s) Checking of Brake liner/car top safety
- t) Checking of Brake operation
- u) Door lubrication

II. Quarterly checking and spares replacement if necessary of the following
